3.The learned Additional Public Prosecutor submitted that there are nine previous cases pending against the petitioner. He further submitted that the respondent police after completing the investigation, has filed a charge sheet on 19.10.2023 through E-filing No.43 of 2023 and it has not been taken on file so far.

4.Considering the submission made by the learned Additional Public Prosecutor, there is no question of bail at this stage. Let the petitioner surrender before the concerned Court and seek regular bail.

5.With the above, this criminal original petition is dismissed.
