Prayer in CRL MP(MD). No.16349 of 2022:-

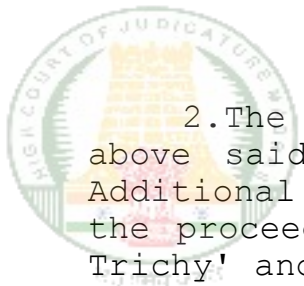
