The present petition has been filed by the wife, seeking transfer of the case in H.M.O.P.No.33 of 2022 pending on the file of the Principal Subordinate Court, Pudukkottai to be transferred to the Subordinate Court, Thirumangalam, Madurai District.

2. The learned counsel appearing for the petitioner / wife submits that the petitioner / wife is a permanent resident of Thirumangalam and she finds difficulty to travel all along to Pudukkottai for every hearing.

3. The learned counsel appearing for the respondent / husband submits that if the case is transferred to Thirumangalam, it will be very difficult for the respondent / husband to reach there from Pudukkottai.

4. In view of the aforesaid facts, H.M.O.P.No.33 of 2022 pending on the file of Principal Subordinate Court, Pudukkottai is hereby withdrawn and transferred to Principal Sub Court, Madurai.
