PRAYER : Criminal Original Petition filed under Section 482 of Criminal Procedure Code, to call for the records in Crime No.100 of 2013 on the file of the Inspector of Police, Pattiveeranpatti Police Station, Dindigul for the alleged offences under Sections 420, 294(b) and 506(1) IPC and quash the same.

ORDER

This Criminal Original Petition has been filed, invoking Section 482 Cr.P.C., seeking orders to call for the records pertaining to the First Information Report in Crime No.100 of 2013 on the file of the first respondent police and quash the same.

2. The case of the prosecution is that that the first petitioner had received a sum of Rs.5,80,000/- from the second respondent for securing a job for the second respondent's daughter, that the first petitioner without securing the job, cheated the second respondent and that when the second respondent asked for the said amount, the petitioners threatened him.

3. When the matter is taken up for hearing today, the learned counsel appearing for the petitioners would submit that the second

respondent has lodged a complaint before the first respondent and on that basis, FIR came to be registered in Crime No.100 of 2013 dated 26.04.2013 for the offences under Sections 420, 294(b) and 506(1) IPC against the petitioners.

4. The case is still under the investigation. Since the amount was paid to the second respondent, the parties have decided to bury their hatchet and compromise the dispute amicably among themselves.

5. A Joint Memo of Compromise has been filed before this Court which have been signed by the petitioners and the second respondent and also by their respective counsel. The petitioners and the second respondent were also present in person before this Court and they were identified by Mr.E.Rajendran, Sub Inspector, Pattiveeranpatti Police Station as well as by the learned counsels appearing for the parties. This Court also enquired both the parties and was satisfied that the parties have come to an amicable settlement between themselves.

6. In the instant case, it is a money dispute and now the parties had compromised. Where the parties have compromised the matter, the High

Court has power to quash the complaint for the offences under Sections 420, 294(b) and 506(1) IPC.

7. The legal position expressed by the Hon'ble Apex Court in the case of ***Gian Singh vs. State of Panjab and another*** reported in ***(2012)10 SCC 303*** and ***Parbathbhai Aahir @ Parbathbhai Vs. State of Gujrath*** reported in ***(2017)9 SCC 641*** were taken into consideration.

8. In the light of the guidelines issued in the above said Judgments of the Hon'ble Apex Court, no useful purpose will be served in keeping the proceedings in Crime No.100 of 2013 pending before the first respondent police, even though, the offences involved are not compoundable in nature.

9. Accordingly, this Criminal Original Petition stands allowed and as a sequel, the proceedings in Crime No.100 of 2013 on the file of the first respondent police, is quashed and the terms of joint compromise memo shall form part and parcel of this order.
