2.The petitioner has sent a representation to the respondents to remove his name from the History Sheet on 21.10.2023. Since the same was not considered till date, he has filed this writ petition seeking direction to consider the same by the respondents. The learned counsel for the petitioner would submit that only on the basis of the FIR registered in Crime No.226 of 2013 on the file of the third respondent police station, the history sheet was opened in respect of the petitioner. Now it is pending before the Sessions Court. It was foisted against the petitioner only due to the election motive.
