This Criminal Original Petition has been filed, invoking Section 482 Cr.P.C., seeking orders to direct the respondents 2 to 4 not to harass the petitioner under the guise of enquiry.

When the matter is taken up for hearing today, the learned Government Advocate (Criminal Side) appearing for the respondents 1 and 2 would submit that the defacto complainant in the above case has filed a petition in Crl.O.P.(MD)No.766 of 2023 seeking direction for filing the final report on the earlier date and this Court has directed the respondent therein to complete the investigation and file a final report within a period of three months from the date of receipt of a copy of that order. He would further submit that subsequent to the occurrence, the petitioner has transferred the JCB and that since the second respondent
