Learned Government Advocate (Crl.side) submitted that a writ petition in W.P(MD)No.25091 of 2023 was filed by this petitioner seeking a direction to the second respondent herein to remove his name from the History Sheet that was entertained and a direction was issued to the concerned authority to consider the representation made by the petitioner in the meeting to be held in the month of December, 2023 and the writ petition was disposed of on 17.10.2023. The said period is not yet over. Even without waiting for the scheduled meeting, this petition is filed seeking direction to the third respondent police.
