For Bail in Crime No. 454 of 2023 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner/ Accused herein, who was arrested on 08.09.2023 for the alleged

offence under Sections 392 of IPC, in Crime No.454 of 2023, on the file of the

respondent police, seeks bail.

2.The case of the prosecution is that on 28.08.2023 at about 12.00 in the midnight when the defacto complainant along with his friend were going in a two wheeler the petitioner along with other accused have intimidated the defacto complainant by showing aruval and had taken two mobile phones and ran away from the place of occurrence. Hence, the case.

3.The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution. He would further submit that the petitioner is in judicial custody from 08.09.2023, hence he seeks bail.

4.The learned Additional Public Prosecutor submitted that investigation has been completed and final report has been filed before the concerned Court. He would further submit that no previous case is pending against the petitioner.

5.Considering the period of incarceration and the fact that the final report has been filed before the concerned Court and also considering the fact that the petitioner has not committed any offence either similar or any other offence , this Court is inclined to grant bail to the petitioner with stringent conditions.

6.Accordingly, this Criminal Original Petition is allowed and the petitioner is ordered to be released on bail, on executing a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.I, Kumbakonam and on further condition that the petitioner shall report before the respondent police daily at 10.30 a.m. until further orders.
