For Bail in Crime No. 130 of 2023 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioners /A1 to A6 herein, who were arrested and remanded to judicial custody on 25.10.2023 for the alleged offence under Sections 379 of IPC and Section 21(1) of Mines and Minerals (Development and Regulations) Act,1957 in Crime No.130 of 2023, on the file of the respondent police, seeks bail.

2. The case of the prosecution is that on 24.10.2023 at about 5.30 a.m., when the police officials were on vehicle check up near Veerakudi Villakku regarding sand theft they found the petitioners quarrying one unit of river sand in bullock cart without any valid permission. Hence a complaint was lodged and a case was registered.

3. The learned counsel for the petitioners submitted that the petitioners are innocent, they have not committed any offence as alleged by the prosecution. They have been falsely implicated in this case. However, to show their bona fide, the petitioners have come forward to deposit a sum of Rs.15,000/- (Rupees Fifteen Thousand only).

4. The learned Additional Public Prosecutor would submit that the petitioners have illegally quarryied one unit of river sand in bullock cart without any valid permission. He would further submit that A4 is having two previous case and A5 is having one previous case.

5. Considering the facts and circumstances of this case, period of incarceration, considering the nature of the mineral involved and and their willingness to pay a sum of Rs.15,000/- (Rupees Fifteen Thousand only), this Court is inclined to grant bail to the petitioners.

6. Accordingly, this Criminal Original Petition is allowed on condition that,

(i) the petitioners shall deposit a sum of Rs.15,000/- (Rupees Fifteen Thousand only) to the credit of the Account Number (A/c.No.7567821433, Indian Bank, High Court Branch Madurai (2001), IFSC Code:IDIB000H040) opened by the Registrar Judicial, Madurai Bench of Madras High Court, Madurai, for donating law books in the name of “Madurai Bench of Madras High Court” in Kalaignar Centenary Library, Madurai, without prejudice to their rights and contentions before the trial Court.

7. On such deposit, the petitioners are ordered to be released on bail, on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) each with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate Thiruchuli, Virudhunagar District, and the petitioners shall file an undertaking affidavit before the trial Court that they will not indulge in any kind of offence in future and on further condition that the petitioners shall report before the respondent police daily at 10.30 a.m. until further orders.
