This criminal original petition has been filed to modify the condition No.3 imposed by the Principal Sessions Judge, Ramanathapuram, in Crl.MP No.4653 of 2023, dated 20/10/2023.

2.The learned counsel appearing for the petitioners would submit that the petitioners filed a petition in Crl.MP No.4777 of 2023 on the file of the Principal District Judge, Ramanathapuram to modify the condition imposed against them, but
