2.The petitioner's request for grant of patta was negated by the fourth respondent. Copy of the same has been served on the learned counsel for the petitioner. The learned counsel for the petitioner states that revision petition will be filed before the second respondent within a period of thirty days. If such a revision petition is filed, the second respondent

The second respondent shall put the interested persons, if any, on notice before passing final order. It is open to the second respondent to pass order one way or the other.
