If the petitioner's civil rights have been affected by the petition mentioned documents, the petitioner has to necessarily move the jurisdictional civil Court for relief. Granting him liberty to move the jurisdictional civil Court, the writ petition stands dismissed. There shall be no order as to costs. Consequently, connected Miscellaneous Petition stands closed.
