PRAYER IN Crl.M.P.(MD)No.10394 of 2022:

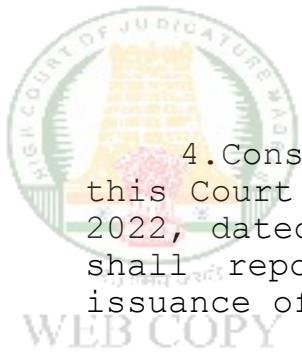
