ORDER

Mr.V.S.Karthik, learned Standing Counsel takes notice for the respondent.

2. The present writ petition has been filed challenging the order passed by the Employees' Provident Fund Organisation under Section 14B and 7Q of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952.

3. Considering the fact that the petitioner is a Primary Agricultural Co-operative Credit Society, the respondent Organisation is directed to keep the 14B order under abeyance till the decision of the Hon'ble Full Bench of this Court. As far as the order under Section 7Q, dated 10.08.2023 is concerned, the petitioner Society is permitted to remit the said amount to the respondent authorities in 6 equal monthly installments to be payable on 10th day of every month in English calendar and the first installment shall start from **10.12.2023**.
