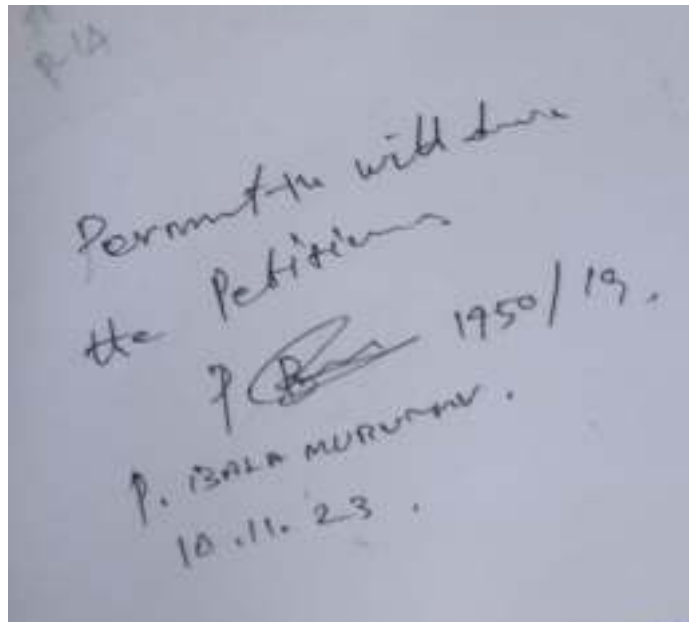
The representation itself has been sent only on 06.11.2023 but the Writ Petition has been filed on 07.11.2023, even before it reaches the
