ORDER

2. The petitioner seeks renewal of his passport. Apprehending that his application will not be processed, this writ petition came to be filed.

3. When the matter was taken up for hearing, the learned Government Advocate submitted that the criminal case registered against the petitioner has since culminated in C.C.No.2343 of 2019 on the file of learned Judicial Magistrate No.III, Tiruchirappalli. The petitioner therefore has to necessarily move the jurisdictional Court for relief .

4. The petitioner is permitted to file an M.P before the learned trial Magistrate seeking the relief now sought for. The learned trial Magistrate will dispose of the said M.P within three weeks after it is filed. I make it clear that I have not gone into the merits of the matter. With this liberty to the writ petitioner to approach the learned Trial Magistrate and direction to the learned Trial Magistrate to give time bound disposal. Registry is directed to mark a
