2.The learned Counsel appearing for the petitioner submits that the petitioner along with four others filed a suit in O.S.No.222 of 2019, before the Principal District Munsif, Sankarankovil, for declaration. The petitioner/plaintiff and the respondents 4,6,7 & 8 are the legal heirs of one Kanthasamy, under Hindu Succession Act. Though the
