AWARD

The present Writ Petition has been filed for a writ of Mandamus seeking compensation for the lands acquired by the National Highways in S.No.120/14-A1 at Kututangkadu Village, Thoothukudi Taluk.

According to the petitioner, no compensation has been paid. The Zonal Deputy Tahsildhar, Thoothukudi has informed that the compensation amount is ready in the office and the parties can approach the District Revenue Officer, Thoothukudi with all relevant documents for receiving compensation. The Zonal Deputy Tahsildar, Thoothukudi, who had appeared before this Court, agreed to pay the compensation on production of all the relevant records. The petitioner has also agreed to receive the compensation.

Recording the same, the Writ Petition stands closed.
