3.The learned Government Advocate (crl.side) appearing for the respondent would submit that the petitioner has been complying with the conditions.



4.Considering the said submission, the condition imposed by this Court in Crl.M.P.(MD)No.12435 of 2022 in Crl.O.P(MD)No.17864 of 2022, dated 18.10.2022 is modified to the effect that the petitioner shall report before the learned Judicial Magistrate No.V, Tirunelveli, on the first working day of Saturday of every English Calender month at 10.30 am until further orders.
