2.The case of the prosecution is that on 27.06.2023, silver articles worth about Rs.34,500/- were stolen by breaking open the door of the defacto complainant's house. Hence the case.

3.The learned counsel appearing for the petitioner would contend that the petitioner is innocent and he has not committed any offence as alleged by the prosecution. He would further submit that the petitioner is in custody from 05.10.2023, hence he seeks bail.

4.The learned Additional Public Prosecutor appearing for the respondent Police would submit that the petitioner is a habitual offender and so many previous cases are pending as against the petitioner. That apart, the finger print also matched and hence, he opposed to grant bail to the petitioner.

5.Heard both sides and perused the materials available on record.
