For Bail in Crime No.230 of 2023 on the file of the Respondent Police.

The petitioner, who was arrested and remanded to judicial custody on 05.10.2023

for the alleged offence punishable under Sections 457, 380 and 511 IPC in Crime No.230 of 2023, on the file of the respondent police, seeks bail.

2.The case of the prosecution is that the defacto complainant owns a house in Curtralam and he is using the same as his office. When he returned back to his office on 17.07.2023, at about 08.00 am., he found that his house was illegally opened and the wardrobe and locker of his office were broken by some unidentified persons. Hence the case.

3.The learned counsel appearing for the petitioner would contend that the petitioner is innocent and he has not committed any offence as alleged by the prosecution. He would further submit that the petitioner is in custody from 05.10.2023, hence he seeks bail.

4.The learned Additional Public Prosecutor appearing for the respondent Police would submit that the petitioner is a habitual offender and so many previous cases are pending as against him and hence, he opposed to grant bail to the petitioner.

5. Heard both sides and perused the materials available on record.
