Writ Petition filed under Article 226 of the Constitution of India, seeking for the issuance of Writ of Mandamus, to forbear the respondents from acquiring the land in Survey No.607/2A, 242/2A, 595/1B, 598/3A, 585/5 and 585/6A to an extent of 0.29.00, 0.15.00, 0.20.00, 0.20.00, 0.38.0 and 0.38 Hectares situated at S.Ramalingapuram Village, Samsikapuram Revenue Village, Rajapalayam Taluk, Virudhunagar District, without following the due process of law and without fixing fair compensation procedure contemplated under Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 by considering the petitioner's representation dated 21.10.2022 within time fixed by this Court.

ORDER

The petitioner's lands in Survey Nos. 607/2A, 242/2A, 595/1B, 598/3A, 585/5 and 585/6A situated at S.Ramalingapuram Village, Samsikapuram Revenue Village, Rajapalayam Taluk, Virudhunagar District, were acquired by the National Highways in the year 2020. However, the respondents have not provided any compensation to the petitioner for acquisition of the said lands. Hence, the petitioner is before this Court.

2. The learned Government Advocate appearing for the respondents 2, 3 and 5, on instructions, submits that for acquisition of the petitioner's land, an award has already been passed and the

compensation amount would be deposited in the petitioner's Bank Account within a reasonable time.

3. Considering the submission of the learned Government Advocate, this writ petition is disposed of with a direction to the third respondent to deposit the compensation amount in the petitioner's Bank Account, within a period of four weeks from the date of receipt of a copy of this order. If the petitioner is having any grievance with regard to the quantum of compensation, it is always open to him to work out his remedy in the manner known to law. No costs. Consequently, connected miscellaneous petition is closed.
