2.The petitioner is the defacto complainant in the C.C.No.29 of 2019. He gave a complaint before the respondent police, which was registered in Crime No.3 of 2018, for the offence punishable under Sections 406, 420, 408, 409, 468, 471, 477A, 120B, 109 of IPC. The grievance of the petitioner is that though the case was registered in the year 2018, so far no progress is made in the trial process.

3.The learned Government Advocate (Crl. Side) would submit that totally fifteen witnesses to be examined in this case. He would further submit that the respondent police is ready to co-operate to complete the trial process within the time stipulated by this Court.

4.In view of the submissions on either side, there shall be a direction to the learned Judicial Magistrate No.I, Ramanathapuram, to expedite the trial process and dispose of the same within a period of **nine** months from the date of receipt of a copy of this order.
