ORDER

2. Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Criminal Side) appearing for the respondent.

When the matter is taken up for hearing today, the learned Government Advocate (Criminal Side) appearing for the respondent would submit that one Mallika has filed a civil suit in O.S.No.608 of 2012, for permanent injunction and the same was ordered to be dismissed for default on 31.10.2022. He would further submit that though the petitioner has already given representation seeking police protection, the same is pending before the second respondent.
