PRAYER :-

For Anticipatory Bail in Crime No.259/2023 on the file of the respondent police

ORDER : The Court made the following order :-

The petitioner/Accused, who apprehends arrest at the hands of the respondent police for the offences punishable under Section 379 of IPC r/w.21(4) of Mines and Minerals (Development and Regulation) Act,1957 in Crime No.259 of 2023 on the file of the respondent police, seeks anticipatory bail.

2.The case of the prosecution is that the petitioner herein along with other accused have illegally transported one unit of tank sand in a tractor bearing Reg. No. TN 67 BA 9532, hence the case.

3.The learned counsel appearing for the petitioner would submit that the petitioner is innocent and a false case has been foisted against him. Hence he seeks anticipatory to the petitioner.

4.The learned Additional Public Prosecutor appearing for the respondent submitted that petitioner herein along with other accused have illegally transported one unit of tank sand in a tractor bearing Reg. No. TN 67 BA 9532 and two similar previous cases are pending against the petitioner, hence he objected to grant anticipatory bail to the petitioner.

5. Taking into consideration the facts and circumstances of the case and also considering the previous bad antecedents of the petitioner this Court is not inclined to grant anticipatory bail to the petitioner.
