3.Considering the gravity of offence committed by the petitioners, this Court finds that there is no change in circumstances. They are not entitled for any discretionary relief from this Court. Hence, the petitioners are directed to surrender before the concerned Court and seek regular bail. Accordingly, this Criminal Original Petition stands dismissed.
