The present writ petition has been filed by the Junior Engineer of the respondent Transport Corporation, who went on voluntarily retirement from service on 28.02.2022.

2.According to the learned counsel appearing for the petitioner, he was not paid for surrender leave salary from 08.12.2008 to 10.12.2011, which covers 45 days and he has also got a grievance that his earned leave has not been credited to his leave account. On the basis of the said request, the petitioner has sent a representation to the respondents, on 03.04.2023.

3.In view of the above said facts, the third and fourth respondents are directed to consider the petitioner's representation, dated 03.04.2023 and if he is found eligible, shall disburse the said amount within a period of twelve
