This petition has been filed to grant interim stay of the operation of the order passed in M.C.No.6 of 2022 dated 18.08.2023, on the file of the learned Judicial Magistrate Court, Aruppukkottai, Virudhunagar District, pending disposal of the above Criminal Revision Case.

2. Heard the learned counsel for the petitioner and also perused the materials available on record.

Considering the facts and circumstances of the case, this Court is inclined to grant interim stay on condition that the petitioner shall deposit 50% of the arrears amount of the maintenance pending as of now to the credit of M.C.No.6 of 2022 on the file of the learned Judicial Magistrate Court, Aruppukkottai, Virudhunagar District, within a period of six weeks from the date of receipt of a copy of this order and further the petitioner is directed to pay 50% of the the monthly maintenance amount to the respondents regularly, failing which the interim stay granted shall
