2. The Status Reports filed by the Commissioner, Dindigul Corporation, Dindigul and the Local Planning Authority, Dindigul, would reveal that the further action to implement the project has been dropped and the land acquisition proposed to be initiated is also dropped.

3. That being the factum, the orders passed by this Court dated 04.10.2018 and 21.02.2018 in W.P.(MD) Nos.11484 of 2018 and 11167 of 2016 are recalled and the review petitions stand allowed. In view of the fact that all further actions were dropped, the Writ Petitions stand closed.
