This Criminal Original Petition has been filed to quash the charge sheet in C.C.No.120 of 2023 on the file of the learned Judicial Magistrate, Nilakottai

2.The learned counsel for the petitioner would submit that though the petitioner sought to quash the proceedings pending against him, now he would restrict his prayer. Also submitted that the petitioner will be satisfied if his personal appearance before the trial Court is dispensed with.

3. Considering the fact that the petitioner is working as a Supervisor in the tasmac shop situated in Dindigul without going into the merits of this case, this Criminal Original Petition is dismissed. Consequently, connected miscellaneous petitions are closed. However, considering the submissions made by the learned counsel for the petitioner, his personal appearance before the trial Court is dispensed with the following condition:
