ORDER : The Court made the following order :-

The petitioner/sole accused, who was arrested and remanded to judicial custody on 05.10.2023 for the alleged offence punishable under Sections 454,457 and 380 of IPC in Crime No.192 of 2023, on the file of the respondent police, seeks bail.

2.The case of the prosecution is that on 27.06.2023 the friend of the defacto complainant called him over phone and informed that his house was found broke open and when the defacto complainant visited his house he found silver articles worth about Rs.34,500/- were stolen. Hence the case.

3. This is the second application for bail and the earlier application for bail was dismissed by this Court on 16.11.2023.

4. Taking into consideration the fact that there is no change in circumstances of the case, this Court is not inclined to grant bail to the petitioner.
