2. The case of the prosecution is that while the defacto complainant went to attend to the relative marriage, the petitioner herein has stolen the cell phone belonging to the him. Hence, the complaint.

3. The leaned counsel appearing for the petitioner would submit that the petitioner is innocent and he has not committed any offence as alleged by the prosecution and his name has been falsely implicated in this case and hence, he seeks anticipatory bail.

4. The learned Additional Public Prosecutor would submit that there are 6 previous cases pending against the petitioner in similar nature and hence, he strongly, opposed to grant anticipatory bail to the petitioner.

5. Considering the serious nature of offence committed by the petitioner and also submission made by the learned Additional Public Prosecutor appearing for the respondent, this Court is not inclined to grant anticipatory bail to the petitioner.

6. Accordingly, this Criminal Original Petition is dismissed.
