This petition has been filed to grant interim stay of the operation of the order passed in M.C.No.53 of 2022 dated 31.08.2023, on the file of the Family Court, Dindigul District, pending disposal of the above Criminal Revision Case.

2. Heard the learned counsel for the petitioner and also perused the materials available on record.

Considering the facts and circumstances of the case, this Court is inclined to grant interim stay on condition that the petitioner shall deposit 75% of the arrears amount of the maintenance pending as of now to the credit of M.C.No.53 of 2022, on the file of the Family Court, Dindigul District, within a period of four weeks from the date of receipt of a copy of this order, failing which the interim stay granted shall stand vacated automatically without further reference to this Court. On such deposit being made by the petitioner, the respondent is permitted to withdraw the deposited amount.
