This Criminal Original Petition is filed to transfer the enquiry to some other agency to conduct further enquiry on the complaint made by the petitioner, dated 17.01.2023 (CSR. 2. The learned Government Advocate (Crl.Side) would submit that on the basis of the complaint given by the petitioner, enquiry was undertaken. During the course of enquiry, both sides appeared. Finding that the issue between the parties is purely civil in nature, it was closed on 17.02.2023.

3. Now the grievance of the petitioner is that subsequent to the above said closure, he gave complaints, dated 09.08.2023 and 06.09.2023.
