This Criminal Original Petition has been filed to direct the 1st respondent to transfer the investigation in Crime No. 72 of 2023 from the 2nd respondent to some other investigation agency by considering the petitioner's representation, dated 06.11.2023.

2.The learned counsel appearing for the petitioner submitted that no proper penal provision has been included in FIR and no proper investigation has been conducted by the investigating officer. The second respondent is pressing the petitioner to withdraw the complaint. Hence, this petition.

3.Per contra, the learned Additional Public Prosecutor submitted that inspite of repeated summons issued to the petitioner, he is not co-operating with the investigation. Except summoning the petitioner for enquiry, no other harassment made by the second respondent.
