Prayer :-

Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records pertaining to the impugned order dated 16.11.2023 in No. 3617/Tha.Ku2/2023 and Quash the same and consequently directing the respondents to grant ordinary leave for 40 days without escort to the life convict prisoner namely, Shakar Kumar, S/o. Natarajan, aged 43 years, bearing Life Convict No. 3617, detained at Cenral Prison, Palayamkottai.

The compliance of the order has been communicated by the Superintendent of Prison, Central Prison, Palayamkottai vide letter dated 22.01.2024.
