3.Considering the facts and circumstances of the case, the condition already imposed on the petitioners is hereby modified to the effect that the petitioners shall execute a **own** bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) to the satisfaction of the learned Judicial Magistrate No.II, Srivaikundam. Accordingly, the Criminal Miscellaneous Petition is allowed.
