ORDER

Let the enquiry be completed within a period of fifteen days from the date of receipt of a copy of this order. If any trouble arises during the course of enquiry, the petitioner is at liberty to work out remedy through appropriate proceedings. There is no harassment at the hands of the respondent Nos.1 and 2.

4. Accordingly, this Criminal Original Petition stands disposed of.
