2. Learned Additional Public Prosecutor submitted that on the basis of the complaint given by the petitioner enquiry was undertaken. During the course of enquiry it was found that in pursuance of the decree passed by the Special Court, Thoothukudi, sale deed was executed in favour of the counter party. So they were advised to work out remedy through appropriate civil proceedings and the complaint was closed.

3. Let a copy of the closure report be served upon the petitioner, so that he can work out remedy, if he is so aggrieved.
