**Prayer :** Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents 1 to 3 to permit the petitioner to repay the original balance Principal Loan amount of Rs.4,90,000/- (Rupees Four Lakhs Ninety Thousand only) along with 10% simple interest from the Arbitration award in ARC No.14/07-08 dated 27.07.2007 as One Time Settlement, as

The petitioner has given a representation in this regard. The third respondent has already passed a resolution and the same has been forwarded to the second respondent. The second respondent is directed to forward the proposal to the first respondent immediately. The first
