According to the learned counsel appearing for the writ petitioner, the petitioner had secured higher educational qualification in May 2016, namely, M.A.(Tamil) and therefore, she is eligible for incentive increment with effect from 01.06.2018. The petitioner has given a representation to the third respondent through the fourth respondent on 22.10.2020. Another representation has been sent by the petitioner on 26.11.2020 to the second respondent herein.

3. Heard the learned counsel appearing for the petitioner and the learned Government Advocate appearing for the respondents 1 to 3.

4. Considering the above said facts, the second respondent herein is directed to consider those representations and pass orders on merits and in accordance with law within a period of eight weeks from the date of receipt of a copy of this order.
