According to the writ petitioner, after his retirement, the trade union and the management have entered into a settlement under Section 12(3) of the Industrial Dispute Act on 04.01.2018 conferring the benefits from 01.09.2016. Seeking the said benefits, the petitioner has sent a representation on 18.03.2023. Since there is no response, the present writ petition has been filed.

3. Considering the above said facts, the respondents 2 and 3 are directed to confer the eligible benefits upon the writ petitioner within a period of twelve (12) weeks from the date of receipt of copy of this order.
