Seeking the said benefits, the petitioner has sent a representation on 11.03.2020. Since there is no response, the present writ petition has been filed.

3. Considering the above said facts, the respondents 2 and 3 are directed to confer the eligible benefits upon the writ petitioner within a period of twelve (12) weeks from the date of receipt of copy of this order.
