Taking advantage of the above said transfer, this petitioner along with the other accused persons alleged to have executed documents by impersonation. The enquiry is now underway.

3.Since it is a case of alleged impersonation, let the petitioner appear before the third respondent and co-operate to complete the enquiry. Depending upon the enquiry process, he can workout his remedy through appropriate proceedings.
