PRAYER : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents to settle the arrears of Dearness Allowance for the periods from January 2018 to March 2018 (3 months), July 2018 to August 2018 (2 months), January 2019 to April 2019 (4 months) and July 2019 September 2019 for total period of 12 months which were not settled till the date of retirement on 31.05.2022 along with belated payment interest at the rate of 6% p.a. from the date of retirement till the date of payment.
