ORDER

The present writ petition has been filed by a concern who are covered by the Employees Provident Fund Act seeking a Mandamus to pay the determined contribution amount in 20 equated monthly installments.

2. The learned Counsel appearing for the petitioner submits that the period covered in the writ petition is the Covid-19 period and based upon the Scheme introduced by the Government, namely, Aatmanirbhar Bharat Rozgar Yojana (ABRY Scheme), wherein they have been directed to pay a sum of Rs.20,67,316/-.

3. Considering the above said facts, the petitioner Mill is permitted to pay the said amount in 10 equated monthly installments starting from **10.01.2024**. All the other installments shall be paid on or before 10th of every month. In case, if there is any default in any one of the installments, the respondent authorities are at liberty to proceed further in accordance with law.
