ORDER

This Criminal Original Petition is filed to direct the first respondent and his police officials that not to interfere into the civil dispute with regard to the properties in Survey Nos.828/4 (435.6 sq.ft) and 827/3 (2613.6 sq.ft) situating in Vembanur Village, Agastheeswaram Taluk, Kanyakumari and not to harass the petitioner and his family members in the guise of the enquiry based on the 2nd respondent's complaint.

2. The learned Additional Public Prosecutor would submit that the dispute arose between the vendor and the purchaser. On the basis of the complaint given by the second respondent herein, enquiry was undertaken.
