ORDER

2. According to the school management, one Mr. J.Leo Joseph was appointed as B.T Assistant (English) in their school on 03.07.2023. The proposal for approval was sent by the school management to the 4th respondent and the same is still pending.

3. Considering the fact that the petitioner school is a stand alone minority institution, the 4th respondent is directed to consider the said proposal and if he is satisfied that the appointment is within the staff fixation order for the

relevant academic year, he shall proceed to approve the appointment of the said teacher with effect from the date of appointment with all attendant benefits. The said exercise shall be completed within a period of twelve (12) weeks from the date of receipt of copy of this order.
