The petitioners can submit their memorandum to the first respondent seeking assignment of alternative sites. It is for the first respondent to take a call in the matter. The petitioners shall not be disturbed for a period of four weeks from today.

4.This writ petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
