No.3750/IFMS/2023 dated 10.07.2023 and the proceeding of the 5th respondent bearing Na.Ka. No.6190/A4/2021 dated 22.11.2023 and to quash the same and consequently direct the respondents to include the correspondent of the school in the level of sanctioner of claiming grant in IFHRMS that is Integrated Financial and Human Resources Management System.

with login credentials. Thereafter, the District Educational Officer, Thuckalay shall contact the concerned treasury office and the concerned treasury officer will provide login credentials. In the presence of the petitioner, the District Educational Officer will arrange the furnishing of the login details. The petitioner is called upon to adhere to the procedure outlined by the learned Additional Government Pleader. The authorities are directed to respond positively. Since the petitioner has been appraised of the procedure to be adopted and since he is agreed to abide by the action, the question of taking punitive action does not arise at all.

3. The Writ Petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petitions are closed.
